
EUTR Normative

The purpose of the European Union Timber Regulation (EUTR) is to stop the illegal timber trade in the EU. Regulation is an important element of the EU Forest Law Enforcement, Governance and Trade Programme, FLEGT.

This regulation gives us the certification to manufacture and / or repair Europalets and EPAL pallet boxes, thus contributing to the system of exchange of logistics material that operates mostly in the world.

Our company can manufacture any type of pallet with 2 inlets (bars) and 4 inlets (studs) adapting the pallet to the needs of the client, according to the type of load and the weight that the pallet has to support.


WE RECYCLE AND REUSE
